PARENTING COORDINATION

Parenting coordinators are experienced mediators in family law, psychology and social work and are appointed by agreement in terms of a Court Order and are mandated to resolve disputes.

- Assist parties in implementing parenting plans
- Help resolve disputes about maintenance
- Advocate for the best interests of the children

HOW CAN FAMAC HELP?

We help provide a more durable outcome and aim at achieving a formal agreement between parties through collaboration. Our approach is holistic, taking into account many factors which adjudication does not.

Our mediators examine the causes and dynamics of the conflicts, interests and positions of the parties.



FAMILY MEDIATORS' ASSOCIATION OF THE WESTERN CAPE

FAMAC has its origins in FAMSA Western Cape, where an interest group was formed in 1988 to look into the possibility of offering a divorce/family mediation service. After training with Lisa Parkinson and Henry Brown of the Family Mediators' Association in the UK FAMAC adopted the FMA training model and became autonomous.

Mediation is a voluntary and confidential process in which parties are helped by a neutral professional (a legal practitioner and or mental health practitioner – social worker or psychologist) to explore possibilites of resolving issues and disputes (any family and divorce related disputes) between themselves by mutual agreement without adjudication.

WHAT IS MEDIATION?

Mediation involves families in conflict working out arrangements for themselves and their children with the help of a neutral and skilled mediator.

THE AIM OF MEDIATION

The aim of mediation is to reach an agreement that is mutually acceptable to the parties within the broad range of that which a court would be likely to approve.

HOW LONG DOES IT TAKE?

Each mediation session usually lasts two hours. The number of sessions needed depends on the nature of the problems – generally, 3 to 6 sessions are necessary. The charges for mediation sessions are payable at the end of each session. Responsibility for payment of mediation fees may be shared between the parties in any way they may agree.

CHALLENGES ADDRESSED

Any or all of the problems that arise when couples split up can be brought to mediation.

- Listens to both parents and helps the them come to a decision
- Arrangements concerning the children eg. drawing up a
- parenting plan and care arrangements
- · Property and financial matters

WHO MEDIATES?

A trained, experienced and accredited mediator can meditate on his/her own. Mediation in the divorce/separation/child-related field may be most effectively and ideally dealt with by two mediators who work together as a team: one an experienced family lawyer and the other an experienced professional trained in marital and family work, usually a psychologist or a social worker.



PARENTING COORDINATION

Parenting coordination was developed to reduce postdivorce/separation conflict. It offers parents a forum to resolve disputes regarding their children or maintenance after they have been divorced or separated, without going to court. Parenting coordinators are experienced mediators in family law and appointed by agreement in terms of a Court Order and are mandated to resolve disputes that arise postdivorce/separation – mainly relating to the best interests of the children.

PARENTING COORDINATORS AND CHILDREN'S NEEDS

Parenting coordinators are not authorized to issue directives around relocation, inside or outside the borders of South Africa. This may vary depending on the parenting plan or the contact arrangements already agreed upon but the parenting coordinator may make a recommendation which is non-binding.

Parenting coordinators frequently deal with disputes regarding contact and holiday arrangements, choices of schooling or any other aspect of the children's lives where the parents need to make joint decisions. Some Court orders also mandate the parenting coordinator to resolve disputes around maintenance but may not vary maintenance orders by issuing a directive. Parenting coordinators, like mediators, are trained by FAMAC in a dedicated 40 hour training course.



WHAT TO EXPECT FROM PARENTING COORDINATORS

Parenting coordinators are authorised to issue directives in certain mandated areas, they mediate and make recommendations that are binding on both parents. These directives can only be varied by a Court of competent jurisdiction or by agreement between the parents.

REQUIREMENTS OF PARENTING COORDINATORS

Parenting coordinators are required to attempt to resolve disputes by way of mediation at first instance. Parenting coordinators are also authorised to speak to all relevant parties including the children, and in some instances it may be necessary for a parenting coordinator to appoint an expert to complete various assessments, which could include contact and care, holiday contact, change of school.

FAMAC'S CORE VALUES

Self-determination

Both parties have the autonomy to make the decisions instead of giving up that power to a neutral third party. The mediator is simply there to guide the conversation to help the parties themselves make the necessary decisions.



Fair and equitable mediation

Mediators act as objective thirdparties to help enhance communications between parties, fostering an improved working relationship.

Creative problem-solving

Through the skilled assistance of a mediator, parties are encouraged to listen, keep confidence, be empathetic, respect each other's values, and focus on resolving underlying conflict.
